### Attendance, Exam and Assignment Adjustment (AEAA) Option 1 Plan (Coordinated between Student and Professor)

**Purpose of the Option 1 Process:** For student and professor to develop a written plan to address the AEAA listed on the Course Accessibility Letter.

#### Details of this accommodation and usage:

- AEAA is only to be used for the disability/medical/health reason on record with SAS. Health or non-health matters not on record, seasonal colds/flu, or COVID do not apply.
- This accommodation is designed to establish a slight amount of flexibility for attendance, test dates and assignment deadlines when a brief, periodic health or medical experience with potential abrupt onset impacts these areas.
- The AEAA is not designed to support a substantial number of missed classes (sporadic or consecutive) or lengthy assignment extensions or lengthy delays in taking an exam. In these cases, reasonable adjustments may not be possible and the student's final grade may be impacted if remaining in the course.
- The provision of a doctor's letter to the professor should not be required to utilize the accommodation since the chronic condition is on record with SAS. (A doctor's letter for reasons beyond this accommodation can be requested).

**Guidance for Students:** Complete **Page 2** before contacting your professor.

**Guidance for Instructors:** The student has opted to work with you directly to identify reasonable options for this accommodation.

- You are receiving this agreement from a student who has a medical condition that is unpredictable in nature. The purpose of this agreement is to determine if additional flexibility exists beyond what is in your syllabus.

**AEAA Need not Fundamentally Alter Course:** If attendance and related activities can be justified as an essential part of how the course is taught and/or how learning is experienced, demonstrated and measured, an AEAA accommodation may potentially be unreasonable. ## **AEAA Guidelines and Mutual Agreement**

Accommodations should not fundamentally alter the core requirements of the course. The AEAA is not designed to allow students to miss an unlimited number of classes, assignments, projects, tests and/or quizzes.

**Expected Communication: The student agrees to communicate with this professor within 24 hours of a missed task if the health condition warranting this accommodation affects participation or attendance. This accommodation cannot be used for any other reason.**

This document is only valid with the professor's above expectations clearly listed on this document or clearly noted elsewhere. Furthermore, both student and professor signatures should be made after the professor lists AEAA expectations and student agrees. The student and instructor should each retain a copy for reference during the semester. We highly recommend someone submit a copy to SAS for accommodation record purposes.

If this plan is met or exceeded during the semester, the student and instructor must communicate an appropriate course of action. While the initial agreement can be adhered to, other options may be possible (examples including but not limited to the student will be granted an incomplete, the student will receive pros and cons of staying in the course or withdrawing from it, the number of absences allowed will be reviewed, etc.) SAS should be informed as soon as possible so they can work with the instructor and student to come to a reasonable solution.
